(4) Within 10 days of the filing of its adoption notice, Fox Run shall issue and file with the Commission in its own name Downstream's tariff, or such other tariff as it proposes to put into effect in lieu thereof, in the form prescribed in Administrative Regulation 807 KAR 5:011, Sections 2 through 5, with proper identifying designation. (5) Downstream shall be responsible for submitting to the Commission a financial and statistical report, as describe in Administrative Regulation 807 KAR 5:006, Section 3, for the period in calendar year 2008 that it owned and operated the transferred assets. (6) The rate-making treatment of the plant acquisition adjustment and any associated costs (i.e., amortization) shall be deferred until Fox Run's next rate proceeding. |
