(5) Notwithstanding Ordering Paragraph 4, if surplus funds remain after approved construction has been completed, utility may use surplus to construct additional plant facility if RD approves and will not result in change in utility's rates for service. Utility shall provide written notice of additional construction in accordance with 807 KAR 5:069, Section 3. (6) Jessamine-South Elkhorn shall notify Commission one week prior to actual start and at 50% completion point. (7) Three years from effective date of Order, Jessamine-South Elkhorn shall file income statement in sufficient detail to demonstrate rates approved are sufficient to meet its operating expenses & debt service requirements. (8) Within 20 days of the date of Order, Jessamine-South Elkhorn shall file with the Commission revised tariff sheets showing rates approved herein. |
