(2) Kentucky Power shall appear at the Commission's offices on the date set forth in Appendix A to submit itself to examination.  
(3) Kentucky Power shall, by the date set forth in Appendix A, files its prepared direct testimony.  
(4) Any party filing testimony shall file an original and ten copies.  
(5) (a) The information requested is due on or before March 20, 2009.  
(5) (b) Each response shall be answered under oath.  
(5) (c) Any party shall make timely amendment to any prior response.  
(5) (d) For any request to which a party fails to furnish requested information, that party shall provide a written explanation for its failure to respond.  
(6) Within 7 days of the Commission granting intervention to a party, Kentucky Power shall provide the party a copy of its monthly environmental surcharge reports.  
(7) Kentucky Power's monthly environmental surcharge reports shall be incorporated b reference into the record of this case.  
(8) The case records of Case Nos. 1996-00489, 2002-00169, 2004-00081, 2005-00068, 2005-00341, and 2006-00307 shall be incorporated by reference into the record of this case.  
(9) Any motions for extensions of time shall be made in writing.  
(10) Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
