(1) Pursuant to KRS 74.455, this proceeding is initiated to determine whether Respondents presently reside within Mountain Water District's territory and whether they are disqualified from continued service as members of Mountain Water District's Board of Commissioners and must be removed from the Board.

(2) Within 10 days of service of this Order, each Respondent shall file with the Commission a written response to this Order and shall specifically admit or deny the allegation that he resides outside Mountain Water District's territory. In this response, each shall further state whether he waives his right to a public hearing.

(3) Unless he waives his right to a public hearing in this matter, each Respondent shall appear at the Commission's offices at 211 Sower Boulevard on July 2, 2009 at 11:00 a.m. for a public hearing.

(4) Pursuant to KRS 278.080, Richard Raff is designated as hearing examiner to conduct the scheduled hearing in this matter.
