(2) The LG&E and KU motion requesting a declaratory Order authorizing the filing of applications for approval of surcharges to recover the costs of purchasing wind power without the necessity of complying with 807 KAR 5:001, Section 10, or, in the alternative, requesting a waiver from the regulation, is denied. (3) That part of the LG&E and KU application requesting approval of long-term wind power contracts will be reviewed and processed independently of the part of the application requesting surcharges to recover the costs to be incurred under those wind contracts. (4) The motion to dismiss or abate filed by the AG and KIUC is denied.
