 (1) The amounts billed by Kentucky Power through its environmental surcharge for the period of July 1, 2009 through December 31, 2009 are approved.  
 (2) Kentucky Power shall use a weighted average cost of capital of 7.96 percent and a tax gross-up factor of 1.5760 in all monthly environmental surcharge filings subsequent to the date of this Order.

 No later than ten days from the date of this Order, Kentucky Power Company shall file a statement of whether there are any material issues of fact that warrant a hearing or whether this case should be submitted for adjudication based on the existing record without a hearing.

 (1) The procedural schedule set forth in Appendix A shall be followed in this proceeding.  
 (2) Kentucky Power shall appear at the Commission's offices on the date set forth in Appendix A to submit itself to examination on the application of its environmental surcharge as billed to consumers from July 1, 2009 through December 31, 2009.  
 (3) Kentucky Power shall file its prepared direct testimony in support of the reasonableness of the application.  
 (4) Any party filing testimony shall file an original and ten copies.  
 (5) a. The information requested herein is due on or before February 25, 2010.  
 (5) b. Each response shall be answered under oath.  
 (5) c. Any party shall make timely amendment to any prior response if incorrect when made.  
 (6) Within seven days of the Commission's granting intervention to a party, Kentucky Power shall provide the party with a copy of its monthly environmental surcharge reports.  
 (7) Kentucky Power's monthly environmental surcharge reports and supporting data for the review period shall be incorporated into the record of this case.  
 (8) Motions for extensions of time shall be made in writing.  
 (9) Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
