EKPC shall be allowed to implement this change by including two months of over- and under-recoveries in the first monthly environmental filing after the date of this Order. 4. Within 20 days of the date of this Order, EKPC shall file its revised Rate ES-Environmental Surcharge tariff reflecting the change discussed herein. 5. EKPC's Member Cooperatives shall include the applicable monthly retail pass-through adjustments shown in the Appendix to this Order in the determination of each Member Cooperative's pass-through mechanism in each of the first two billing months following the date of this Order, as discussed herein.
- 6. The 16 Member Cooperatives identified in the Appendix of this Order shall be authorized to discontinue the use of the two-month "true-up" adjustment and return to the practice that was in place prior to the final Order in Case No. 2009-0
