(5) If NKWD has not sold the proposed bonds within 180 days of this Order, it shall advise in writing and further advise of the reasons for the delay in sale and expected date of sale. (6) Any provision of the Order of December 22, 2010 that conflicts with the provisions of this Order is revoked and rescinded. (7) NKWD's proposed rates are denied. (8) The rates as set forth in Appendix A are approved for service rendered by NKWD on and after the date of this Order. (9) The rates as set forth in Appendix B are approved for service rendered on and after January 1, 2012. (10) NKWD's proposed revisions to its rules and regulations are approved.
