- (3) All documents that Grayson filed with the Commission pursuant to 807 KAR 5:056, Section 1 (7) and (9) during the period under review are incorporated by reference into the record of this proceeding.
- (4) Grayson shall publish notice no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in trade publication or newsletter going to all customers. Grayson shall file an Affidavit of Publication of Hearing Notice with the Commission no later than October 8, 2010.
- (5) The official record of the proceeding shall be by video only.
