- (1) HCWA is granted a Certificate of Public Convenience and Necessity.
- (2) HCWA's proposed plan of financing with RD is accepted.
- (3) HCWA is authorized to issue its Waterworks Revenue Bonds from the RD loan in the amount of \$885,000 at an interest rate not exceeding 3.625 percent per annum, maturing over 40 years.
- (4) The proceeds from the loan agreement with RD shall be used only for the purposes specified in HCWA's application.
- (5) If surplus funds remain after the construction has been completed, HCWA may use such surplus to construct additional plant facility if RD approves.
- (6) HCWA shall file a copy of the "as-built" drawings and a certified statement that the construction has been completed in accordance with contract plans within 60 days of completion.
- (7) HCWA shall require the construction to be inspected under the supervision of a professional engineer with a Kentucky registration.
- (8) HCWA shall monitor the adequacies of the expanded water distribution system after construction.
- (9) HCWA shall notify the Commission one week prior to the start of construction and at the 50 percent completion point.
- (10) Any documents filed in the future shall reference this case number and shall be retained in the utility's general correspondence file.
