(2) Kentucky Power shall pay the amount of \$2,500 within 30 days of the date of this Order by cashier's check or money order made payable to the Kentucky State Treasurer and mailed or delivered to the Office of General Counsel, Public Service Commission. (3) Kentucky Power shall require its Kentucky Safety Manager to attend AEP's 2011 "Public Liability Accident Investigation Training." Kentucky Power shall file a report with the Commission within 30 days after its Kentucky Safety Manager attends AEP's training seminar, verifying his attendance and providing a copy of the agenda for the training seminar. (4) Within 12 months of the issuance of this Order, Kentucky Power shall require its Kentucky Safety Manager to attend a training seminar provided by a professional organization certified to instruct accident investigation and reconstruction methods for the electric utility industry in accordance with accepted professional standards and the NESC. Kentucky Power shall file a report with the Commission within 30 days after its Kentucky Safety Manager attends the training seminar, verifying his attendance and providing a copy of the agenda for the training seminar.

(5) Upon payment of \$2,500 by Kentucky Power, this case shall be closed & removed from Commission's docket without further Order.

the failure of Kentucky Power to document and investigate the conditions at the incident site after it became aware of the June 15, 2009 contact incident and prior to removing the service drop.

- (7) Any request for an informal conference with Commission Staff shall be set forth in writing and filed with the Commission within 20 days of the date of this Order.
