Not less than 7 days nor more than 21 days prior to the scheduled hearing, Kentucky Power shall publish in a newspaper of general circulation in its service territory of Knott County, Kentucky, notice of the May 3, 2011 hearing, including the due date for filing notices of intent to attend, and stating that the hearing shall be cancelled if no notice to attend is filed by April 29, 2011. 3. Kentucky Power shall file proof of publication of its notice for the hearing with the Commission no later than April 29, 2011. 4. The official record of the proceeding shall be by video only
