As there is no line loss adjustment for direct served customers shall deduct 6.39 mills per kWh from the base energy rate applicable to its direct served customer 3. The rates in the Appendix to this Order are approved for service rendered on and after June 1,2011, the effective date of East Kentucky's change in rates. 4. Within 20 days of the date of this Order, shall file revised tariff sheets with the Commission setting out the rates approved herein and reflecting that they were approved by this Order.
