 (1) Boone District is authorized to issue the 2011 Refunding Bonds in an amount not to exceed \$1,900,000 for the purpose of refunding the outstanding 2001 Refunding Bonds, but only under such terms and conditions as will produce both positive gross savings and net present value savings. (2) If the actual terms and conditions of the proposed 2011 Refunding Bonds differ from those proposed 2011 Refunding Bonds of \$1,708,787 as set forth in its application, Boone District shall, within 30 days of issuing the 2011 Refunding Bonds, file with the Commission amortization schedules and work papers showing the actual gross savings and net present value savings that will result from the refinancing. (3) Within 30 days of issuing the 2011 Refunding Bonds, Boone District shall file with the Commission a statement setting forth the date on which the bonds were issued, the actual interest rates, and the principal amount. (4) The proceeds from the transaction authorized herein shall be used only for the lawful purposes specified in the application. (5) Any documents filed pursuant to ordering paragraphs 2 and 3 of this Order shall reference the number of this case and shall be retained in the utility's general correspondence file.
