2. Ballard is granted deviation from the filing requirements in ordering paragraph 3.d. of the Commission's May 29, 2013 Order. Ballard's proposed increases in basic local exchange service rates, as set forth in the tariffs attached to its application filed June 11, 2013, are approved.
4. Ballard's motion for an extension of time in which to file responses to the Commission's Order of May 29, 2013, is granted.
5. Within 20 days of the date of this Order, Ballard shall file using the Commission's electronic Tariff Filing System its revised tariff sheets containing the rates approved herein and signed by an officer of the utility authorized to issue tariffs, shall reflect that they were approved pursuant to this Order, and shall contain an effective date of June 1, 2013.
6. Any future increases to basic local exchange rates necessitated by the FCC's ICC/USF Order shall be filed as an application in compliance with Commission regulations.

2. Movant's request for confidential treatment for the information contained in Exhibit 7 to the Application is denied.
3. The information in Exhibit 6 to Movant's Application shall not be placed in the public record or made available for public inspection for five years, or upon further Order of this Commission. At the end of this period, the material shall be placed in the record. The Movant may request the material continue to be treated as confidential, but must demonstrate that the material still falls within the exclusions established in KRS 61.878.

- 05/29/13 Order Entered: Ballard Rural's proposed rates for its basic local exchange service are suspended for one day from the effective date of May 31, 2013, and will be effective subject to refund on June 1, 2013. 2. Within ten days of the date of this Order, Ballard Rural shall file with the Commission an application to support its proposed tariff to increase rates for local exchange service. The application shall comply with 807 KAR 5:001, Section 16, except for any waivers that may be granted or requirements other than those specified in the findings above.
3. The application shall also contain: a. The estimated annual revenue to be received from High Cost Loop Support beginning July 1, 2013.
b. The estimated annual revenue to be lost due to adjustment of terminating access rates effective July 1, 2013. c. The total estimated annual revenue (increase or decrease) to be generated by the tariff changes. Include a breakout for each service or category of service to show changes in revenue. d. Historical and projected line counts and the effects of any line changes on the company.
