(3) KU shall file with the Commission no later than October 11, 2013 proof of publication of its notice for the hearing. (4) The official record of the proceeding shall be by video only. (5) a. The information requested in the Appendix to this Order is due not later than 21 days from the date of this Order. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided. b. Each response shall be answered under oath or be accompanied by a signed certification of preparer or person supervising preparation of response on behalf of entity that response is true and accurate to best of that person's knowledge, information, and belief formed after a reasonable inquiry.
