04/29/14	Final Order Entered: (1) Beginning January 1, 2014, Kentucky Power's environmental surcharge billing factor will be zero percent, per the terms of the Settlement agreement in Case No. 2012-00578, and is to remain at that level until changed by the Commission. (2) Kentucky Power shall not collect the net under-recovery of \$3,518,900 per ordering paragraph 1 and the terms of the Settlement Agreement in Case No. 2012-00578. (3) Kentucky Power shall use a weighted average cost of capital of 8.08 percent and a tax gross-up factor of 1.5489, a return on equity rate of 10.50 percent, and an overall grossed-up return of 10.69 percent in all monthly environmental surcharge filings subsequent to the date of this Order. (4) Kentucky Power shall continue to submit its monthly environmental surcharge filings for the period that the monthly billing factor is fixed and maintained at zero percent. (5) Other than the net under-recovery of \$3,518,900 discussed in this Order, the charges and credits billed by Kentucky Power through its environmental surcharge for the period July 1, 2011 through June 30, 2013 are approved.
