Big Rivers Electric Corporation ("Big Rivers") shall appear in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, on April 10, 2014, at 10:00 a.m., Eastern Daylight Time, to submit itself to examination on the application of its Fuel Adjustment Clause ("FAC") from May 1, 2013, through October 31, 2013.
