Power purchases in excess of the fuel cost of its highest-cost generating unit available to be dispatched to serve native load during reporting expense month that have been recovered through Duke Kentucky's FAC since the end of the review period shall be disallowed in future FAC review proceedings. 4. The issue of RTO billing codes & appropriateness of their inclusion in FAC calculation shall be examined in next FAC review proceedings covering two-year period November 1, 2012, through October 31, 2014, for those electric utilities that are members of an RTO. 5. Duke Kentucky shall file testimony in next FAC review proceeding on which codes are included in FAC calculation and an explanation for why each is appropriate for inclusion, subject to recovery limitation discussed in this Order. 6.
