Any other aerial maps based upon a survey or based upon the certified territory map signed by Grayson and Kentucky that show the boundary line delineating the service territories of Grayson and Kentucky Power, and clearly identify the 11 residences in the Valley View Subdivision that Grayson asserts lie within Grayson's service territory. 2.
