Warren District shall require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in civil or mechanical engineering to ensure that the construction work is done in accordance with the contract drawings and specifications and in conformance with the best practices of the construction trades involved in the project. 5. Warren District is authorized to enter the proposed Assistance Agreement with KIA and, under the terms of that agreement, to borrow from KIA an amount not to exceed \$1,090,050 to be repaid over a 20-year period at an interest rate of 3.0 percent per annum. 6. Within 30 days of executing its proposed Assistance Agreement with KIA, Warren District shall file with the Commission an executed copy of the Assistance Agreement. Warren District shall use \$1,090,050 of the proceeds from the proposed Assistance Agreement with KIA only

for the lawful purposes set forth in its application.
