LG&E shall appear on October 11, 2016, at 9:00 a.m. Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of presenting evidence concerning the alleged violations of KRS 278.042, the most recent edition of NESC, and the LG&E Safety Manual, and showing cause why it should not be subject to the penalties prescribed in KRS 278.990(1) for these alleged violations. 3. The October 11, 2016 hearing shall be recorded by videotape only. 4. The Staff Report in the Appendix to this Order is made a part of the record in this case. 5. At the scheduled hearing in this matter, LG&E shall also present evidence on the adequacy, safety, and reasonableness of its practices related to the construction, installation, and repair of electric facilities as they relate to the facts of this case and whether such practices require revision as related to this incident. 6. Any request for an informal conference with Commission Staff to discuss the issues in this case shall be set forth in writing and filed with the Commission within 20 days of the date of this Order.
