Northern District is granted a CPCN to proceed with the proposed construction as set forth in its application. 2. Northern District shall notify the Commission prior to performing any additional construction not expressly authorized by this Order. 3. Any deviation from the construction approved by this Order shall be undertaken only with the prior approval of the Commission. 4. Northern District shall not begin construction on the project until the USACE and Fort Thomas have issued their permits for this project. Northern District shall file a copy of the permit, certification, approval, or document within ten days of obtaining each permit, certification, approval or document, 5, Northern District shall require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in civil or mechanical engineering to ensure that the construction work is done in accordance with contract drawings and specifications and in conformance with best practices of construction trades involved in project. 6. Northern District shall submit an application to the Commission prior to issuing any securities that require approval pursuant to KRS 278.300. 7. Northern District shall file documentation of the total costs of this project, including the cost of construction and all other capitalized costs within 60 days of the date that construction authorized under this CPCN is substantially completed.
