The remaining \$30,000 of the civil penalty shall be suspended on the condition that Flemingsburg complies with the ordering paragraphs 3, 4, and 5 of this Order within the timeframe allowed. 3. Within three months of the date of this Order, Flemingsburg shall provide, through a qualified third party, additional mandatory training to all employees who work on or near natural gas

qualified third party, additional mandatory training to all employees who work on or near natural gas facilities on the requirement to remove each potential ignition source from any area where gas is being vented into the open air. 4. Within three months of the date of this Order, Flemingsburg shall provide, through a qualified third party, additional mandatory training to all supervisors of employees who work on or near natural gas facilities regarding the proper procedure for post-incident drug and alcohol testing. 5. Within 30 days of completion of the training ordered in ordering paragraphs 3 and 4 of this Order, Flemingsburg shall certify to the Commission in writing that it has completed such training.
