Final Order Entered: 1. The motion to dismiss Clark Pollitt and Amanda Pollitt is denied in part and granted in part. 2. The motion to dismiss Clark Pollitt as a party to this proceeding is denied. 3. The motion to dismiss Amanda Pollitt as a party to this proceeding is granted. 4. Basil Pollitt, Clark Pollitt, and Pollitt Enterprises, jointly and severally, are assessed a civil penalty of \$57,500 for violation of KRS 278.140, KRS 278.160, and 807 KAR 5:006, Section 4(2). 5. Basil Pollitt, Clark Pollitt, and Pollitt Enterprises shall pay the \$57,500 assessed civil penalty within 30 days of the date of this Order by cashier's check or money order payable to the Kentucky State Treasurer, and mailed or delivered to the Office of the General Counsel, Kentucky Public Service Commission, 211 Sower Boulevard, Post Office Box 615, Frankfort, Kentucky, 40602. 6. Basil Pollitt, Clark Pollitt, and Pollitt Enterprises shall tender, within 30 days of the date of this Order, a tariff that complies with KRS 278.160 and 807 KAR 5:011 as a natural gas distribution utility. 7. Basil Pollitt, Clark Pollitt, and Pollitt Enterprises shall file, within 30 days of the date of this Order, an annual report of gross earnings from intrastate business for calendar year 2016, in a form designated by the Commission.
