On January 1 of each calendar year, with the first filing starting on January 1, 2019, and the last filing to be filed on January 1, 2021, West Carroll shall file with the Commission a report that documents West Carroll's specific efforts to reduce unaccounted-for water loss and any progress that it has made as a result of those efforts. 6. Any documents filed subsequent to the date of this Order shall be retained in the post case reference file. 7. This case is now closed and removed from the Commission's docket.

Its written comments on and any objections to the findings contained in the Commission Staff Report; and b. Any additional evidence for the Commission to consider. 3. If Commission Staff finds that West Carroll's financial condition supports a higher rate than West Carroll proposes or the assessment of an additional rate or charge not proposed in West Carroll's Application, West Carroll in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the additional rate or charge. 4. If Commission Staff finds that changes should be made to the manner in which West Carroll accounts for the depreciation of West Carroll's assets, West Carroll in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should require West Carroll to implement the proposed change for accounting purposes.

The Attorney General shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order. 3. The Attorney General shall comply with all provisions of the Commission's regulations, 807 KAR 5:001, Section 8, related to the service and electronic filing of documents. 4. Pursuant to 807 KAR 5:001, Section 8(9), within seven days of entry of this Order, the Attorney General shall file a written statement with the Commission that: a. Certifies that it, or its agent, possesses the facilities to receive electronic transmissions; and b. Sets forth the electronic mail address to which all electronic notices and messages related to this proceeding should be served.
