afforded by law.

Eastern Rockcastle shall continue to operate the water system until the closing of the transaction, at which time Kentucky American will begin operating the system and

serving the customers. 6. No later than July 1, 2018, Eastern Rockcastle shall submit its Annual Report for 2017, and the Gross Report for 2017 and 2018 through the date of the transfer. 7. Eastern

Rockcastle shall submit the journal entries associated with the transfer of the Eastern Rockcastle water system within 30 days of the date of closing. 8. Kentucky American shall submit the journal entries
