Kentucky-American shall obtain an interest rate from American Water Capital that is no greater than the lowest available rate to Kentucky-American or the average rate available on bonds issued by American Water Capital. 4. At least 15 days prior to Kentucky-American's issuance of any notes or debentures that have been authorized herein, Kentucky-American shall notify the Commission in writing of the proposed issuance. In this notice, Kentucky-American's President and Treasurer shall certify under oath the amount of the issuance and that the debt issuance does not exceed the total amount authorized in this Order.
