cashier's check or money order payable to the Kentucky State Treasurer and mailed or delivered to the office of the Kentucky Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky 40602.

3. The PSC will hold a damage prevention training course at its offices located at 211 Sower Boulevard, Frankfort, Kentucky, on November 4, 2019, at 1 p.m. Fastern Daylight Time. If Mr. Cullum

Boulevard, Frankfort, Kentucky, on November 4, 2019, at 1 p.m. Eastern Daylight Time. If Mr. Cullum attends the above training course and pays on or before November 4, 2019, the sum of \$100, the additional sum of \$1,150 shall be vacated, and Mr. Cullum shall not be required to pay it. If Mr. Cullum either does not attend the training course or fails to pay the \$100 specified herein, the entire fine of

\$1,250 will be immediately due and payable.
