Glover Creek shall plant native evergreen species as a visual buffer to mitigate viewshed impact at locations shown and in the manner described in the site development plan in Attachment A of the Site Assessment Report for planting areas and described in Section 2 of the application. The evergreen shrubs shall be either mature at the time of planting of at least six

feet in height, or if Glover Creek elects to plant non-mature evergreen shrubs of at least 3 feet at the time of planting, Glover Creek shall also include additional temporary buffers that would immediately help to mitigate any potential noise and visual impacts until the evergreen

shrubs have grown to maturity. 2. The eighth mitigation measure in the Siting Board's Order of September 23, 2020, is hereby eliminated and replaced with the following mitigation measure: 8. If the pile driving activity occurs within 1,500 feet of a noise sensitive receptor,

Glover Creek shall implement a construction method that will suppress the noise generated during the pile driving process (i.e., semi-tractor and canvas method; sound blankets on fencing surrounding the solar site; or any other comparable method).
