BREC shall immediately notify the Commission upon knowledge of any material changes to Projects A or C including but not limited to, increase in cost, any significant delays in construction, any need to relocate Project C, or any changes in the route of the transmission line not expressly authorized by this Order. 5. BREC shall file "as-built" drawings or maps of within 60 days of the completion of the construction authorized by this Order. 6. BREC shall furnish documentation of the total costs of this project including the cost of construction and all other capitalized costs, including, but not limited to, engineering, legal, and administrative expenses,

within 60 days of the date construction is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for electric utilities prescribed by the Commission.
