Joint Applicants shall file the approval for the construction and operation of the proposed facility from the Kentucky Airport Zoning Commission within six months of the date of service of the Order. 4. Documents filed, if any, in the future pursuant to ordering paragraphs 2 or 3 herein shall reference this case number and shall be retained in the post-case correspondence file. 5. This case is closed and removed from the Commission's docket.
