Within 60 days of the date of service of this Order, Atmos shall refund to its customers all amounts collected for service rendered from October 2, 2022, through the date of entry of this Order that are in excess of the rates set forth in the Appendix B herein attached to this Order. 6. Within 75 days of the date of service of this Order, Atmos shall submit a written report to the Commission in which it describes its efforts to refund all monies collected in excess of the rates that are set forth in the Appendix B to this Order. 7. The Commission reserves its right to initiate an investigation to determine whether Atmos reasonably refunded all monies collected in excess of the rates that are set forth in the Appendix B to this Order should the Commission deem it necessary. 8. This case is closed and removed from the Commission's docket.
