The wastewater service rates proposed by Edmonson District are denied. 3. The rates set forth in the Appendix to this Order are approved for services rendered by Edmonson District on and after the date of service of this Order. 4. Within 20 days of the date of service of this Order, Edmonson District shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and their effective date, and stating that the rates and charges were authorized by this Order. 5. Edmonson District shall use the midpoint of the depreciable lives of

the National Association of Regulatory Utility Commissioners ranges, as proposed in the application and agreed upon by Commission Staff, to depreciate wastewater plant assets for accounting purposes in all future reporting periods. 6. Edmonson District shall file an application for an adjustment in base rates for its sewer division within five years of the date of service of this Order to ensure that its rates are sufficient, or in the alternative, file a formal motion with a detailed analysis of its rates and revenues and a statement explaining the reasons why no modifications are necessary. 7. This case is closed and removed from

the Commission's docket.
