Kentucky Frontier is granted a deviation to the line loss limiter from 5 percent to 7.5 percent in its GCR rate reports for a period of up to two years. The deviation to the line loss limiter will become effective in Kentucky Frontier's next quarterly GCR rate report filing with a proposed effective date of May 1, 2024. 4.
