

Amendment to Large Volume Natural Gas Service Agreement

This AMENDMENT dated May 24, 2017, amends and modifies the Large Volume Natural Gas Service Agreement dated June 1, 2010, (the "Agreement") between ATMOS ENERGY CORPORATION ("Atmos") and [REDACTED] ("Customer")

WHEREAS, Atmos and Customer entered into the Agreement whereby Atmos agreed to provide and Customer agreed to pay for certain natural gas services described in the Agreement; and

WHEREAS, Atmos and Customer desire to amend the Agreement.

NOW THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. Section "1. Natural Gas Service Type and Volume Levels" shall be amended by deleting the following paragraph: "Upon prior notice by Customer, in addition to the above specified maximum daily service requirements, ATMOS shall use reasonable commercial efforts to deliver, [REDACTED]"

Additionally, this Section shall be amended by deleting the table

Table with 2 columns: Tariffs, Maximum Mcf/Day. Row: Firm Carriage Service, [REDACTED]

And replacing with the following table

Table with 3 columns: Service, Maximum Mcf/Day, Maximum Mcf/Hour. Row: Firm Transportation (T-4 Tariff), [REDACTED], [REDACTED]

- 2. Section "2. Price", is hereby amended by deleting the words "The Simple Margin for all volumes delivered under Firm Carriage Service shall be [REDACTED] per Mcf" and in their place the words "Throughout the Term of this Agreement, the simple margin for all volumes delivered each month shall be in accordance with the following schedule:

Beginning on the effective date of this Amendment, the simple [REDACTED] per Mcf.

3. Section "3. Term" is deleted in its entirety and replaced with the following:

"Section 3. Term. This Amendment is subject to approval by the Commission and shall become effective on June 1, 2017 (or the first day of the month during which it is approved the Commission, if later) and shall continue in full force and effect for a period of twelve (12) years ("Initial Term") and thereafter for successive one (1) year renewal terms unless and until terminated by either party upon written notice 180 days prior to the end of the Initial Term or any subsequent renewal term. Such termination shall become effective at the end of the then current term."

4. Section "4. Notices" is hereby renumbered as Section 5 and amended by deleting the words

And a new Section 4 is inserted between Section 3 and the renumbered Section 5 as follows:

installation, maintenance and replacement by ATMOS of additional facilities and/or equipment, including, but not limited to, electronic flow measurement equipment and cellular equipment which will be required as a result of receiving Firm (Rate T-4) service and will provide electric support services therefore. Such equipment will be owned and operated by ATMOS."

5. All references in the General Terms And Conditions To Large Volume Natural Gas Service Agreement to "Firm Carriage Service" are replaced with "Firm Transportation Service (T-4 tariff)".

Except as provided for herein, all other provisions of the Agreement, as amended, are hereby confirmed by the parties to be and remain in full force and effect.

The parties understand that the terms of this Amendment are subject to the approval of the Kentucky Public Service Commission and, as such, will not be in effect until such approval has been granted.
