

5. The corporation is not transacting business in Kentucky.

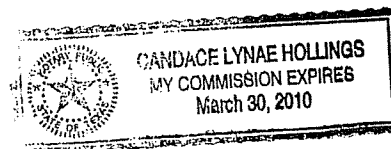
6. The corporation hereby surrenders the authority to transact business in Kentucky.
