***Re: West Kentucky Networks, Inc.'s Proposed Sale of Certain Wireless Assets to Crossroads Wireless, Inc., a Tennessee Provider of Wireless Services***

Dear Ms. O'Donnell:

We are legal counsel to West Kentucky Networks, Inc. ("West Kentucky"). Please return a file-stamped copy of this letter to us in the enclosed self-addressed, stamped envelope.

The purpose of this letter is to inform the Public Service Commission of the Commonwealth of Kentucky (the "Commission") of West Kentucky's proposed sale of certain wireless assets to Crossroads Wireless, Inc. ("Crossroads"), a Delaware corporation.

The general structure of this transaction (the "Transaction") is as follows.

- Crossroads will purchase all of West Kentucky's right, title, and interest in and to West Kentucky's assets associated with its cellular system in Tennessee 1 - Lake Rural Service Area and its personal communications system in the Paducah-Murray-Mayfield, Kentucky Basic Trading Area.
- The Transaction will be strictly a cash transaction, and West Kentucky is the seller. Thus, neither West Kentucky nor Crossroads will incur any indebtedness, nor will any entity or individual receive or grant any security interest in its assets in connection with the Transaction.

- There are no existing cellular customers on West Kentucky's cellular system in Tennessee 1 - Lake Rural Service Area.
- The existing wireless broadband customers on West Kentucky's personal communications system in the Paducah-Murray-Mayfield, Kentucky Basic Trading Area have all received the attached notice with respect to the termination of their wireless broadband service. (See Exhibit 1.)
- The Transaction has been approved by the board of directors of both Crossroads and West Kentucky.
- Closing of the Transaction is expected to occur before October 31, 2007 (but not sooner than one day after the delivery of this letter), and West Kentucky will advise the Commission upon closing.
- The Transaction will not result in the acquisition or transfer of ownership, control, or the right to control either West Kentucky or Crossroads.



Kentucky law does not require Commission approval of the Transaction, as this transaction relates only to the sale of certain assets used in connection with unregulated services, but consistent with the Commission's January 8, 1998 order in *In the Matter of: Exemptions for Providers of Local Exchange Service Other Than Incumbent Local Exchange Carriers*, this letter constitutes at least one days' prior notice describing the transaction.
