By this letter, American International Telephone, Inc. ("AIT"), pursuant to the Kentucky Public Service Commission's ("Commission's") policy regarding name changes, hereby notifies the Commission of AIT's name change to Interoute-Retail, Inc. ("Interoute").

Pursuant to the Commission's Order in Case No. 96-200 dated August 21, 1996, AIT is authorized to provide resold interexchange telecommunications services in the State of Kentucky.


As required by the Commission, the name change has been registered with the Kentucky Secretary of State. A copy of the Amended Certificate of Authority of a Foreign Corporation reflecting the name change issued by the Secretary of State is annexed as Exhibit A. As required by the Commission, a tariff adoption notice is annexed as Exhibit B.

The proposed name change will have no effect on the day-to-day operations of AIT. The services currently offered by AIT to its customers will not be affected by the name change. In other words, AIT is the same company now under a different name.
