- (4) The names and qualifications of operating personnel and any other evidence to show owners have financial, technical, and managerial abilities to provide adequate, reasonable, and efficient service: See Exhibit B which is attached hereto, which contains biographies for Officers and Directors of Maxcess, Inc., and Exhibit C which is attached hereto, which contains Maxcess, Inc.'s Balance Sheet as of November 30, 1999 and Income Statement for 11 months ended November 30, 1999.
- (5) Attached hereto as Exhibit D is a Proposed Interexchange Tariff for Maxcess, Inc. A local exchange tariff will be filed upon completion of interconnection/resale agreements and prior to commencing service.
- (6) Interconnection / Resale Agreement. Maxcess, Inc., is in the process of entering into an Interconnection and/or Resale Agreements with the incumbent local exchange carriers in Kentucky.
