Re: Notification of Assignment of FCC Licenses from Bell Industries, Inc. to SkyTel Spectrum, LLC, and of the Resale of SkyTel Spectrum's Wireless Messaging Services by ST Messaging Services, LLC

## Dear Sir or Madam:

This letter is being provided to notify the Kentucky Public Service Commission ("Commission") and Commission staff of the assignment of Federal Communications Commission ("FCC") licenses authorizing the provision of one-way and two-way wireless messaging services (the "Messaging Services") from Bell Industries, Inc. ("Bell Industries") to SkyTel Spectrum, LLC ("SkyTel Spectrum"), and the resale of the Messaging Services to end user customers by ST Messaging Services, LLC ("ST Messaging").

Specifically, SkyTel Spectrum will acquire several FCC licenses authorizing provision of the Messaging Services from Bell Industries. Consent to this transaction was granted by the FCC by *Public Notice* Report No. 4600 (released December 17, 2008). SkyTel Spectrum and Bell Industries will consummate that transaction in the near future. In the meantime, SkyTel Spectrum is using the spectrum under the FCC licenses that it will acquire to provide the Messaging Services pursuant to a spectrum leasing arrangement permitted under the FCC's rules and of which the FCC has been notified.<sup>1</sup>

Further, pursuant to a transaction that was consummated on March 25, 2009, which did not require FCC approval, ST Messaging will resell to retail subscribers the Messaging Services provided by SkyTel Spectrum. SkyTel Spectrum will operate solely as a wholesale provider, and will not sell its Messaging Services to end user customers.

ST Messaging is a wholly-owned subsidiary of Messaging Management Services, LLC ("MMSLLC"), a recently-created joint venture between American Messaging Services, LLC ("AMSLLC"), SkyTel Spectrum and North American Wireless Holdings, LLC ("NAWLLC").
