Dear Mr. Dorman:

This letter constitutes formal notice that Shared Communications Services, Inc. ("SCS"), its parent, Advanced TelCom Group, Inc. ("ATG") (together, the "ATG Companies") and VFS Financing, Inc. (VFS") completed a transaction whereby ATG became a wholly owned, direct subsidiary of VFS as a part of the emergence of ATG and its operating subsidiaries from their Chapter 11 bankruptcy status. This parent-level transaction also effected the indirect transfer of control of ATG's operating subsidiary, SCS, which currently is authorized to provide telecommunications service within the Commonwealth of Kentucky. On April 2, 2003, the ATG Companies and VFS filed with the Kentucky Public Service Commission (the "Commission") an Informational Filing regarding the proposed parent-level transaction, and describing the transaction in greater detail.

As the transaction occurred at the parent company level, there has been no change to ATG's certificated operating subsidiaries, and SCS continues to offer competitive telecommunications service to consumers within Kentucky pursuant to the same authority.
