ARTICLE I

Name

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

Purposes

The purpose for which this corporation is organized is to engage in any activity within the purposes for which corporations may be organized under the Kentucky Business Corporation Act.


